Prezados colegas do Paraná, envio essa mensagem em Inglês de forma a facilitar o diálogo com nosso colega Sanjaya.

Dear Rubel, Eduardo and Fanny.

Sometime ago I have mentioned the opportunity to have a training provided by UN that aims drafting and monitoring a Resilient City Action Plan. Such an opportunity will be beneficial for Paraná given its local Disaster Risk Management arrangements and strategy. Also, let me highlight that it is not an activity under the World Bank project been implemented at the State level, but rather a good deal of luck as such knowledge will surely indirectly contribute to the Disaster Risk Management Strengthening Project been developed by the State.

Having said that, our colleague from UN (Mr. Sanjaya) has indicated the possibility to deliver the training sessions (around 3 working days) around late April / early May 2015. In general terms, UN is responsible for all costs involved in bringing the staff while the State of Paraná would need to provide a venue for the event, mobilize participants (Civil Defense, Planning and Finance Secretariats, Environment Secretariat, Geological Services, members of academia, etc), hire an interpreter for simultaneous translation (the sessions are delivered in English) and translate some of the materials (some examples are attached) as well as print the resources needed.

Finally, along with some discussions with Capitan Eduardo and Sanjaya, we think the best institution to coordinate would be CEPED given its direct management from State authorities and close link with local universities. Such an arrangement is key for the initiative as one of the aims is to leave the capacity behind so CEPED could eventually both deliver and monitor future progresses in the short term.
